Flush filter by running water through filter according to cartridge instructions.

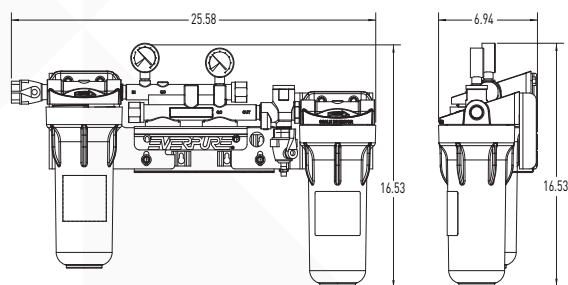
