Equipped with a pressure relief button to relieve water pressure during cartridge changes

INSTALLATION TIPS

Choose a mounting location suitable to support the full weight of the system when operating

Install vertically so bowls hang down

Allow 2-1/2" (6.35 cm) clearance below the cartridge for easy cartridge replacement

Make sure o-ring on bowl is sufficiently

Always screw on bowls by hand; do not use a housing wrench

Flush filter by running water through filter according to cartridge instructions

OPERATION TIPS

Change cartridges on a regular six (6) month preventative maintenance program

Change cartridges when capacity is reached or when pressure decreases

Always inspect o-ring; change and/or lubricate if necessary

Clean bowl with mild solution of detergent before inserting new cartridge

Always flush the filter cartridge at time of installation and cartridge change


