## GENERAL INSTALLATION / OPERATION / MAINTENANCE REQUIREMENTS

Not recommended for use with a Reverse Osmosis (RO) water filtration system – eventual damage to the pump will result. To prevent damage, install with a booster pump or autoclave.

Minimum requirements for incoming water – Water pressure: 14.5 psi; 0.5 gpm (use a booster pump to increase water requirements)

Install a pressure reducer when water pressure exceeds 43.5 psi.

Install the appliance away from heat sources and direct sunlight.

Do not install the appliance outdoors or in damp locations.

Minimum installation space – 2.5 inches from adjacent surfaces for proper air circulation around appliance.

The appliance generates heat, so external venting may be required when it is installed in a cabinet.

Appliance must be supported on all four foot pads.

Correct water pressure is necessary for proper operation of carbonation feature.

Carbonated water operation – For proper pump operation, water must always be present in the cooling circuit.

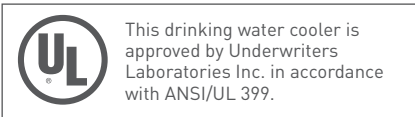
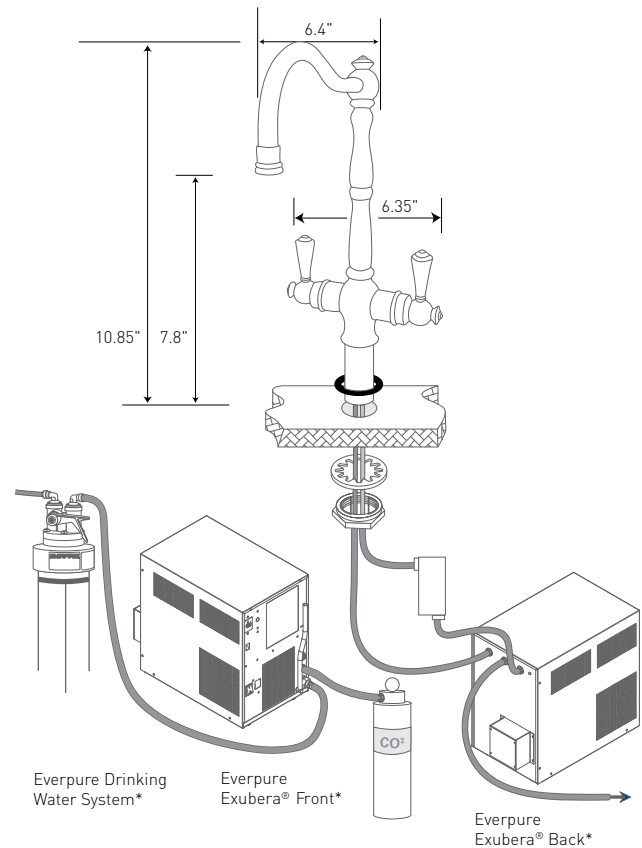
