INSTALLATION TIPS

- ◆ Feed water connection to system should be COLD only. Tempered water up to 80°F (26.6°C) can be used.
- ◆ Do not exceed system specifications for temperature and pressure.
- ◆ Provide a dedicated water line of at least 1/2" I.D. to the unit for consistent flow and pressure to the system.
- ◆ Allow 3" clearance below system for filter cartridge removal and replacement.
- ◆ Connect filtered water line to steam production connections only. Do not use for condenser and wash-water.
- ◆ Detailed installation, operation and maintenance manual are included with each system.

SIZING

- ◆ Drain Connection: 2.0 gpm Minimum Flow
- ◆ Storage Tank Capacity: 50 gals.

OPERATION TIPS

- ◆ Change cartridges on a regular six (6) month preventative maintenance program.
- ◆ Change cartridges when capacity is reached or when flow becomes too slow.
- ◆ Always flush the filter cartridge at time of installation and cartridge change.

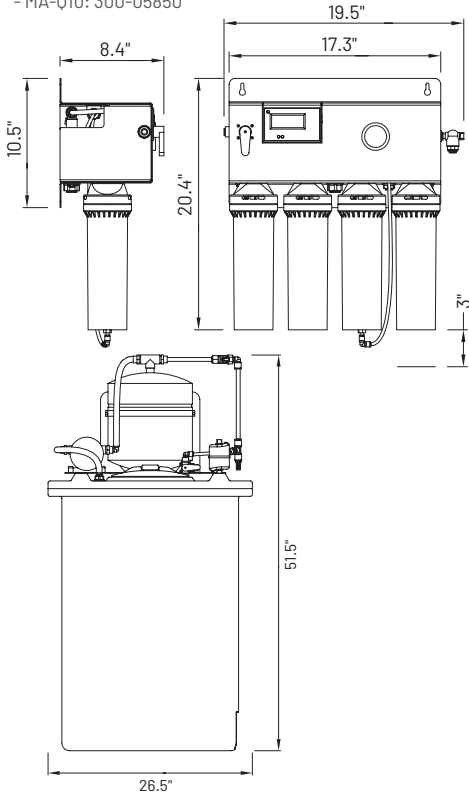
