

INSTALLATION TIPS	OPERATION TIPS	SIZING
Never use saddle valve for connection. Use 3/4" water line.	Change cartridges on a regular six (6) month preventative maintenance program.	Service Flow Rate: Maximum 10 gpm (37.8 Lpm)
Do not connect system to water-cooled condenser.	Change cartridges when capacity is reached or when pressure falls below 10 psi (0.7 bar).	
Install vertically with bowls hanging down.	Service flow rate must not exceed 10 gpm (37.8 Lpm). Always flush the filter cartridge at time of installation and cartridge change.	
Allow 2-1/2" (6.35 cm) clearance below the cartridge for easy cartridge replacement.		
Flush cartridges by running water through system for five (5) minutes at full flow.
