High capacity allows system to keep up with high water demands and allows for 12-month estimated cartridge change-outs

## INSTALLATION TIPS

Choose a mounting location capable of safely supporting the full weight of the system when in operation.

Use 3/4" water line.

Fountain equipment connections are made to the outlet part of the system before the Everpure 2SR-BW Feeder System.

Coffee brewer and ice machine connections are made after the Everpure 2SR-BW Feeder System; a tee is required.

Install vertically with cartridges hanging down and allow 5" (12.7 cm) clearance below the cartridge for easy replacement.

Frame is designed to mount on 16" centers (wall studs).

## OPERATION TIPS

Hollow fiber cartridge life is approximately three (3) years.

Replace quick-change cartridges on a regular 12-month preventative maintenance program.

Always flush the filter cartridges at time of installation and cartridge change.

Flush cartridges by running water through flushing valve for five (5) minutes at full flow.

Electrical outlet is required to operate the backflushing of the system.

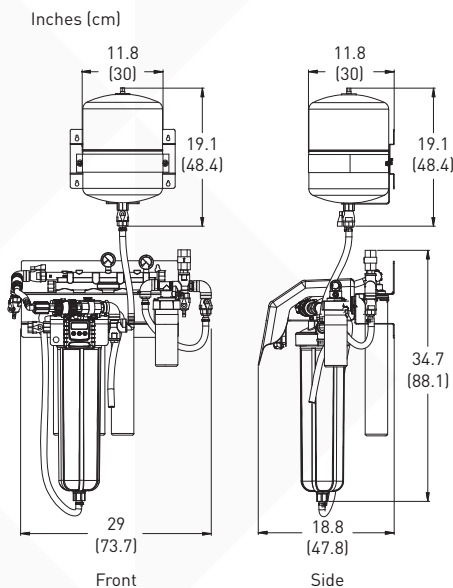
