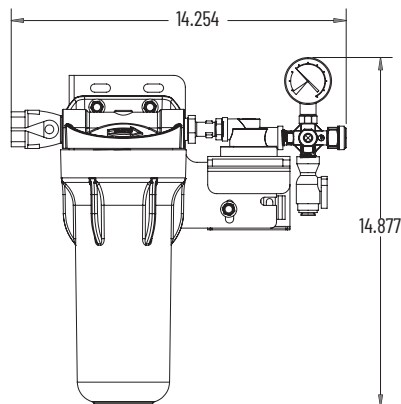

INSTALLATION TIPS

- ◆ Choose a mounting location suitable to support the weight of the system while operating.
- ◆ Install vertically and allow 2 1/2" (6.35 cm) clearance below the cartridge for easy removal and replacement.
- ◆ Flush filter by running water through the system for five (5) minutes.
- ◆ For more details, see the installation, operation, and maintenance guide included with the system.
- ◆ Do not install where the system could be exposed to freezing temperatures.
- ◆ Replace cartridges annually, or when capacity is reached or flow slows down.
