INSTALLATION TIPS

Allow $2\frac{1}{2}$ " (6.35 cm) clearance below the cartridge for easy cartridge replacement.

The water inlet must supply a minimum of 40-85 psi (2.7-5.8 bar), non-shock.

Delime equipment prior to installation.


