Leveraging proprietary technology, the **EZ-RO 650/16ATM** system uses Reverse Osmosis (RO) to reduce Total Dissolved Solids (TDS); it provides up to 650 gal/day $(2,460 \text{ L/day})^*$ and includes a 16-gallon (60.6 L) atmospheric tank. Ideal for applications where RO is necessary to meet manufacturer's warranty requirements[†].




INSTALLATION TIPS

- Feed water connection to system—should be COLD only. Tempered water up to 80°F (26.6°C) can be used.
- Do not exceed system specifications for temperature and pressure.
- Provide a dedicated feed water supply connection of at least 3/8" inner diameter.
- For use with steam generation only.
 Do not use for condensate or wash water.
- Allow 3" clearance below system for filter cartridge removal and replacement.
- Detailed, illustrated installation guide is included with each system.


