## INSTALLATION TIPS

- ◆ The water inlet must supply a minimum of 40-85 psi (2.7-5.8 bar), non-shock.
- ◆ Delime equipment prior to installation.

## OPERATION TIPS

- ◆ Replace the Everpure 4FC5 Pretreatment Carbon Filter Cartridge, the 4CC Post Treatment Calcite Feeder and the Pentair GRO-75EN RO Membrane Cartridge every 12 months.

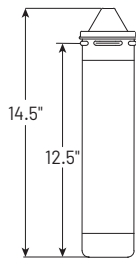

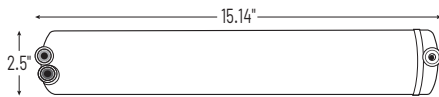
