Non-Pentair Pentek

Pentair warrants to our active Pentair Pro Dealers for the products and for the durations set forth under the "Extended Warranty" columns all set forth in the above charts, if purchased in the US or Canada, that such covered products will be free from defects in material and workmanship for the Extended Warranty Period from the date of original installation (unless otherwise noted). For purposes of clarity, the "Standard Warranty" column in the charts above are for comparative purposes ONLY, and the Extended Warranty is not in addition to the Standard Warranty period. Program subject to annual updates. To be considered as an "active" Pentair Pro Dealer, an eligible participant must have agreed to Pentair's Pro Dealer Program terms and conditions and made purchased at least three Pentair products subject to the warranty program within a twelve (12) month period preceding the warranty claim. Additionally, Dealer must have been a Pentair Pro Dealer program member at the time of installation.

Our warranty will not apply to any product that has been subject to negligence, misapplication, corrosive or abrasive conditions, improper installation or maintenance. In the event a three-phase submersible $motor\ is\ to\ be\ operated\ with\ single-phase\ power,\ we\ recommend\ the\ use\ of\ a\ Pentair\ Pentek^{\otimes}\ variable\ frequency\ drive,\ otherwise\ our\ warranty\ is\ void.$

Buyer's only remedy and Pentair's only duty is to repair or replace defective products (at Pentair's choice). Buyer agrees to pay all labor and shipping charges associated with this warranty and to request warranty service through the installing Pentair Pro Dealer as soon as a problem is discovered. If a warranty service is requested more than 30 days after the Warranty Period has ended, it will not be honored. WARRANTY IS NON-TRANSFERABLE.
